## **AMENDMENT OF POLICY**

#### DEFINITIONS

1. In this policy, "the Policy" means the National Policy on the conduct, administration and management of the assessment of the Senior Certificate, Government Gazette, No. 26789 of 17 September 2004 as amended in Government Gazette Vol. 508, No. 30371 of 11 October 2007.

#### AMENDMENT OF PARAGRAPH 13(5) OF THE POLICY

- 2. *Paragraph 13(5)* is hereby amended by the substitution for *paragraph 13(5)* of the following paragraph:
- "2. The common deadline for the registration of part-time candidates should be [31 January of the] <u>30 September prior to the year of examination</u>."
