CIVIL AVIATION ACT, 2009 (ACT NO. 13 OF 2009)
SECOND AMENDMENT OF THE CIVIL AVIATION REGULATIONS, 2011.

I, Dipuo Peters, Minister of Transport hereby in terms section 155(1)(z)(i), read with section 74(1) (a), of the Civil Aviation Act, 2009, (Act No. 13 of 2009), makes the Regulations as set out in the schedule hereunder.

SCHEDULE

Definition

1. These Regulations, unless the context otherwise indicates, means the Civil Aviation Regulations, 2011, (hereinafter referred as to as “the Regulations”) published by Government Notice No.425 of 1 June 2011 and Government Notice No.R.781 of 28 September 2012, as amended by Government Notice No. R. 533 of 30 July 2013.

Amendment of regulation 1.00.1 of the Regulations

2. Regulation 1.00.1 is herewith amended by the insertion of the following definition after the definition of “diplomatic bag”:

“**Director of Investigations**’ means an official of the Authority as such appointed by the Minister of Transport”.

Insertion of regulation 12.01.1A of the Regulations

3. The following regulation is herewith inserted into the Regulations after regulation 12.01.1:

“Reporting”

12.01.1.A (1) In terms of the Memorandum of Agreement entered into between the Minister of Transport and the Authority in accordance with section 4(1) of the Act, the Department of Transport shall take over the operational responsibility of the accident and incident function

(2) The Accident and Investigation Division of the Authority shall report to the Chief Director: Civil Aviation of the Department of Transport in respect of accident and incident functions.”.

Amendment of regulations 12.01.2-12.01.9, 12.02.2 to 12.02.5, 12.03.2-12.03.3, 12.04.2 and 12.04.3, 12.05.1 to 12.05.3 and 12.06.1-12.06.4 of the Regulations

4. Regulations 12.01.2 to 12.01.9, 12.02.2 to 12.02.5, 12.03.2 to 12.03.3, 12.04.2 and 12.04.3, 12.05.1 to 12.05.3 and 12.06.1 to 12.06.4 are herewith amended by the substitution for the expression “Director” of the expression “Director of Investigations” in the referred to regulations where the former expression appears.

Amendment of regulations 12.05.2 and 12.05.3 of the Regulations

5. Regulations 12.05.2 and 12.05.3 is herewith amended by the substitution in sub-regulations (1), (3), (4), (5), and (6) for the expression “Director” of the expression “Minister”.

Amendment of regulation 174.00.1 of the Regulations

6. Regulation 174.00.1 is herewith amended by the insertion of the following sub-regulation after sub-regulation (2):

“(3) The technical standards for regulation 174.00.2 are contained in Document SA-CATS 174”.

Short title and commencement

7. This Amendment shall be called the Second Amendment of the Civil Aviation Regulations, 2011, and shall come into operation on the date of publication in the Gazette.
