AMENDMENT TO THE TERMS OF REFERENCE OF THE COMMISSION OF INQUIRY INTO ALLEGATIONS OF FRAUD, CORRUPTION, IMPROPRIETY OR IRREGULARITY IN THE STRATEGIC DEFENCE PROCUREMENT PACKAGE

Under the powers vested in me by section 1 of the Commissions Act, 1947 (Act No. 8 of 1947), I hereby amend, with effect from 4 November 2013, the Terms of Reference of the Commission of Inquiry into allegations of fraud, corruption, impropriety or irregularity in the Strategic Defence Procurement Package as published under Proclamation No. R.926 in *Government Gazette* No. 34731 of 4 November 2011, as indicated in the Schedule hereto.

This Proclamation shall come into effect on 4 November 2013.

Definition

1. In this Proclamation "Terms of Reference" means the terms of reference published under Proclamation No. 926 in *Government Gazette* No. 34731 of 4 November 2011.

Amendment of the Terms of Reference

- 2. The Terms of Reference is hereby amended by the substitution for paragraph four (4) of the following paragraph:
 - "4. The Commission shall submit interim reports and recommendations to the President from time to time and at least every six months prior to the finalisation of its report for presentation to the President. The Commission shall complete its work [within a period of two years from date hereof] by no later than 30 November 2014 and shall submit its final report to the President within a period of six (6) months after the date on which the Commission has completed its investigation."

Commencement

3. The amendment to the Terms of Reference published under this Proclamation shall come into operation on 4 November 2013.
