## AMENDMENTS AGREED TO

# NATIONAL RESEARCH FOUNDATION BILL [B 100-97]

#### CLAUSE 1

- 1. On page 2, in line 27, after "with" to insert "primary".
- 2. On page 2, in line 31, before "knowledge" to insert "includes indigenous technology, and means".

#### **CLAUSE 3**

1. On page 4, in line 2, after "technology" to insert ", including indigenous knowledge".

## **CLAUSE 4**

- 1. On page 4, after line 7, to insert the following paragraph:
  - (b) stimulate, promote, support and protect research in the field of indigenous technology;
- 2. On page 4, from line 9, to omit paragraph (c) and to substitute:
  - (c) allocate funds for research and promote multi-disciplinary collaboration through the divisions;
- 3. On page 4, in line 24, to omit "and operate" and to substitute:
  - , support and monitor the operation of
- 4. On page 4, after line 27, to add the following paragraphs:
  - (n) compile and maintain a national registry of research funded by the Foundation;
  - (o) initiate liaison with structures involved in the protection of intellectual property rights.
- 5. On page 4, in line 33, to omit "5(2)" and to substitute "5(3)".
- 6. On page 4, after line 45, to add the following subsection:
  - (4) The Foundation may not itself conduct research other than research regarding the efficient and effective execution of its functions referred to in subsection (1).

### **CLAUSE 5**

Clause rejected.

#### **NEW CLAUSE**

1. That the following be a new Clause to follow Clause 4:





#### National facilities for research

- **5.** (1) The Minister may by notice in the *Gazette* determine a research facility as a national facility under the control of the
- (2) Any researcher or research institution may, subject to such conditions as the Foundation may determine, apply to utilise a national facility for research or instruction.
- (3) The Foundation may not acquire, or manage the operation of, any research facility other than a national facility placed under the control of the Foundation under subsection (1).

#### **CLAUSE 6**

- On page 6, from line 8, to omit subsection (2) and to substitute:
  - (2) (a) For the purposes of appointing the members of the Board referred to in subsection (1)(a), the Minister must appoint a panel which must compile a shortlist of candidates of no more than 20 names.
  - (b) The panel must compile the shortlist after following a transparent and competitive nomination process.
  - (c) The members of the Board referred to in subsection (1)(a) must be appointed by the Minister after consultation with the relevant committees of the National Assembly and the National Council of Provinces and after consideration of the shortlist of candidates.
- On page 6, from line 14, to omit subsection (4) and to substitute: 2.
  - (4) The members referred to in subsection (1)(a) are appointed in their personal capacities, but the Minister must ensure that they are broadly representative of the following sectors:
  - (a) Tertiary education;(b) business;

  - (c) agricultural and environmental sciences;
  - (d) health sciences;
  - (e) natural sciences and engineering;
  - (f) social sciences and humanities;
  - (g) civil society.

#### CLAUSE 10

On page 8, in line 18, to add the following: 1.

> The appointment must be made after following a transparent and competitive nomination process.

# CLAUSE 19

- 1. On page 12, in line 36, after "invention" to insert ", discovery or improvement".
- On page 12, after line 39, to insert the following subsection: 2.
  - (2) The Foundation must, with regard to studies or research supported by the Foundation-
  - (a) acknowledge any invention, discovery or improvement in respect of indigenous knowledge and technology held by any person or community; and
  - (b) protect any rights of that person or community arising from the invention, discovery or improvement.





#### **CLAUSE 22**

Clause rejected.

#### **NEW CLAUSE**

1. That the following be a new Clause to follow Clause 21:

## Structural organisation of Foundation

- **22.** (1) The Board must within 180 days after its first meeting complete the structural organisation of the Foundation in accordance with the operational requirements of the Foundation.
- (2) The structural organisation and any subsequent reorganisation must be carried out in accordance with section 189 and any other applicable provisions of the Labour Relations Act, 1995 (Act No. 66 of 1995).

- On page 16, in the fourth line, after "FRD" to insert:
