MILITARY OMBUDSMAN BILL [B 9—2011]

LONG TITLE

- On page 2, first line, to omit "the Office of the Military Ombudsman" and to substitute "an independent Office of the Military Ombud".

That the following be the new clause:

Mandate of Office

- 4. (1) The mandate of Office is to investigate complaints lodged in writing by—
- (a) a member regarding his or her conditions of service;
- (b) a former member regarding his or her conditions of service;
- (c) a member of the public regarding the official conduct of a member of the Defence Force; or

(d) a person acting on behalf of a member.

(2) For the purposes of this section, conditions of service bear the same meaning assigned to it under section 1 of the Defence Act, 2002 (Act No. 42 of 2002), as amended.

CLAUSE 5

(3) Due regard must be given to-

(a) participation by the public in the nomination process;

(b) transparency and openness; and

(c) the publication of a shortlist of candidates for appointment.

(4) The Ombud must-

- (a) possess adequate knowledge of the Constitution and must have legal knowledge; and
- (b) have knowledge of or experience in military and public administration that was gained over a period of 10 years.".

- (c) the adoption by the National Assembly of a resolution calling for the removal of the Ombud from office.
- (10) A resolution of the National Assembly concerning the removal of the Ombud from office must be adopted with a supporting vote of a majority of the members of the National Assembly.".
