### **RE: LUTHANDO MBINDA DISCIPLINARY HEARING FINDINGS AND RECOMMENDATIONS: TUESDAY 13 JUNE 2017**

2. We place on record that you have failed to attend today the 13 June 2017 disciplinary hearing without giving any reason(s) and or tangible reason(s) for your failure.
3. We advised that the disciplinary hearing continued in your absence.
4. The National Disciplinary Committee has inherent jurisdiction to adjudicate upon all matters, acts of misconduct which relate to or involve;
  - 4.1 Any member of the NEC in terms of Clause/section 23.1.5.1
  - 4.2 Any PAC member of Parliament/Legislature or Council in terms of Clause/section 23.1.5.2
  - 4.3 Any matter between any component structure and other organs(s) or component structure(s) of the PAC in terms of Clause/section 23.1.5.4

- 4.4 Any matter between two or more provinces, or between two regions in different provinces.
5. The hearing was scheduled to start at 10:00 on the 13 June 2017 you and your representative of records Deputy President of the PAC Sibusiso Xaba failed to attend the hearing despite NDC previous postponement giving you the opportunity to attend.
6. The NDC made a ruling that the hearing continues without your presence and your legal representative as no request for postponement had been received or any reason provided for your failure to attend the hearing.

7. The NDC has found you guilty as charged and has recommended that you be expelled from the PAC
