APPLICATION FOR AMENDMENT OF RADIO FREQUENCY SPECTRUM LICENCE BY RHYTHM FM

- 1. The Independent Communications Authority of South Africa ("the Authority") hereby gives notice of receipt of a letter with revised technical specifications from Rhythm FM for amendment of its Radio Frequency Spectrum (RFS) Licence application which was lodged on 03 April 2017 in terms of the provision of section 31 (4) of the Electronic Communications Act, No. 36 of 2005 (ECA) read with Regulation 9 of the Radio Spectrum Frequency Regulations of 2015 ("RFSR 2015") as published in Government Gazette No. 38641 (as amended).
- 2. Rhythm FM now seeks to add six (6) transmitters within its licensed area of the Eastern Cape Province. The proposed additional transmitters will be located at Butterworth, Graaff-Reinet, Kareedouw, Noupoort, Port Elizabeth, and Queenstown. The details and specifications of the application are contained in the table below.
- 3. Interested persons are invited to submit written representation in relation to the application within twenty-one (21) working days from the date of the publication of this notice in the government gazette.

Rhythm FM shall be entitled to respond in writing to written representations made by interested persons on the amendment application, and such written response must be lodged with the Authority within twenty-one (21) days of the date of publication of this notice in the Government Gazette. If the public hearing is held, only the persons who lodged the representation will be allowed to present.
- 8. Rhythm FM must, at the time of lodging such written response, furnish proof to the Authority's satisfaction that it has delivered a copy of such response by hand **OR** has sent a copy of such response by registered mail **OR** by fax **OR** by email to the relevant person(s) having made such written representations.
