


GOVERNMENT NOTICES • GOEWERMENTSKENNISGEWINGS**DEPARTMENT OF HEALTH****NO. 227****15 MARCH 2018****Adjustment of benefits payable by the CCOD****ANNEXURE A****OCCUPATIONAL DISEASES IN MINES AND WORKS ACT, 1973 (ACT 78 OF 1973):****AMENDMENT OF AMOUNTS TO INCREASE BENEFITS**

I, Dr Aaron Motsoaledi, Minister of Health, hereby, after consultation with the Advisory Committee, in terms of section 105A of the Occupational Diseases in Mines and Works Act, 1973 (Act No. 78 of 1973) ("the Act"), amend the following amounts appearing in sections 80(2) and 80(3) of the Act so as to increase affected benefits, with effect from 1 April 2018, as follows:

- a) the amount representing the person's earnings, specified in section 80(2) of the Act increases from R3 000 (three thousand rand) to R4 014 (four thousand and fourteen rand); and
- b) the amount specified in section 80(3) of the Act increases from R 34 458 (thirty-four thousand four hundred and fifty eight rand) to R46 105 (forty six thousand one hundred and five rand).
- c) 1 April 2018, being the date on or after which:
 - (i) an examination to determine the presence, nature and degree of a compensable disease was conducted; or
 - (ii) the first of such examinations commenced; or
 - (iii) a post-mortem examination was partially or wholly conducted on the person who allegedly died of a compensable disease.

WET OP BEDRYFSIEKTES IN MYNE EN BEDRYWE, 1973 (WET 78 van 1973)**WYSIGING VAN BEDRAE OM VOORDELE TE VERHOOG**

Ek, Dr Aaron Motsoaledi, Minister van Gesondheid, na raadpleging met die Advieskomitee, verklaar hiermee, kragtens artikel 105A van die Wet op Bedryfsiektes in Myne en Bedrywe (Wet No. 78 van 1973) ("die Wet"), dat die bedrae per artikel 80(2) en 80(3) van die Wet, gewysig word, om verwante voordele te verhoog, effektiel 1 April 2018, as volg:

- a) die bedrag wat die persoon se verdienste verteenwoordig, uiteengesit in Artikel 80 (2) van die Wet, word verhoog van R3 000 (drie duisend rand) na R4 014 (vier duisend en veertien rand); en
- b) die bedrag, uiteengesit in Artikel 80 (3) van die Wet, word verhoog van R34 458 (vier en dertig duisend vier honderd agt en vyftig rand) na R46 105 (ses en veertig duisend een honderd en vyf rand).
- c) 1 April 2018 synde die datum waarop of waarna:
 - (i) 'n mediese ondersoek ondergaan is om die teenwoordigheid, aard en graad van 'n vergoedbare siekte te bevestig; of
 - (ii) die eerste mediese ondersoek ondergaan is in 'n reeks mediese ondersoeke; of
 - (iii) 'n nadoodse ondersoek in geheel of gedeeltelik uitgevoer is op 'n persoon wat vermoedelik gesterf het aan 'n vergoedbare siekte.
