AGRICULTURAL PRODUCT STANDARDS ACT, 1990 (ACT No. 119 OF 1990)

**REGULATIONS REGARDING THE CLASSIFICATION AND MARKING OF MEAT INTENDED FOR SALE IN THE  
REPUBLIC OF SOUTH AFRICA: AMENDMENT**

The Minister of Agriculture, Land Reform and Rural Development has, acting under section 15 of the Agricultural Product Standards Act, 1990 (Act No.119 of 1990), made the regulations in the Schedule.

## SCHEDULE

### **Definitions**

1. In this Schedule, “**the Regulations**” means the regulations published by Government Notice No. R. 55 of 30 January 2015.

### **Amendment of regulation 1 of the Regulations**

2. Regulation 1 of the Regulations is hereby amended by --

(a) the substitution for the definition of “mass” of the following definition:

“‘**mass**’ with regard to a carcass, means the warm mass as determined at the time of meat classification;” and

(b) the insertion, after the definition of “**treated meat**”, of the following definition:

“‘**week**’ with regard to the age of a boar carcass, means the the first week of the year which is the earliest week with at least 4 days of the month January and where Monday is the first day of the week.”.

### **Amendment of regulation 2 of the Regulations**

3. Regulation 2 of the Regulations is hereby amended by the insertion of the following sub-regulation after sub-regulation (3):

“(4) The restriction in sub-regulation (1)(c) above shall, where necessary, not apply in the following instances: Provided that the assignee shall be informed in writing on an annual basis by the abattoir concerned:

(a) Roller-marking of calf, bovine, sheep and goat carcasses, as prescribed in regulations 17, 18 and 19, when such carcasses are destined for export or processing.

(b) Applying of classification stamp marks on pig carcasses, as prescribed in regulation 15, when such carcasses are destined for export or processing: Provided further that classification markings shall still be indicated on the ears.”.

### **Amendment of regulation 6 of the Regulations**

4. Regulation 6 of the Regulations is hereby amended by the substitution for sub-regulation (4) of the following sub-regulation:

“(4) All carcasses that are slaughtered at a registered abattoir shall at all times, for the purpose of age classification, be identifiable with the head of such a carcass by attaching same numbered stickers to the carcass and corresponding head: Provided that in the case of the head the sticker shall consist of a label permanently attached to the head”.

### **Amendment of regulation 11 of the Regulations**

5. Regulation 11 of the Regulations is hereby amended by --

(a) the substitution for sub-regulation (1) of the following sub-regulation:

“(1) A pig carcass, including the head, with a mass of 20 kg or less on the day of slaughter shall be classified as the class ‘Sucking pig’.”;

(b) the substitution for sub-regulation (2) of the following sub-regulation:

“(2) A pig carcass, including the head, with a mass of 20,1 kg or more but not more than 110 kg on the day of slaughter, shall be classified as a class as stipulated in column 1 of Table 3 of the Annexure, if the calculated percentage meat of the carcass is as specified in column 2 of the table opposite the class concerned: Provided that boar carcasses up to the age of 22 weeks of which the number of the week of birth --

- (a) has been marked clearly on one or both of the ears, may be included up to 110 kg; or
  - (b) has not been marked clearly or not marked at all on one or both of the ears, be included up to 100 kg only.”;
- and
- (c) the substitution for sub-regulation (3) of the following sub-regulation:
- “(3) A pig carcass, including the head, with a mass of 110,1 kg or more on the day of slaughter or 100,1 kg or more for boar carcasses with the week of birth mark not clear or without the week of birth mark on the ear(s), shall be classified as the class ‘Sausage pig’.”.

#### **Amendment of regulation 12 of the Regulations**

6. Regulation 12 of the Regulations is hereby amended by --

- (a) the substitution for sub-regulation (1) of the following sub-regulation:
- “(1) The percentage meat of a pig carcass shall be calculated after --
- (a) the fat thickness and muscle thickness have been measured by means of an electronic thickness meter between the 2nd and 3rd last rib, and 60 mm from the midline of the carcass, while the carcass is in a hanging position;
  - (b) the fat thickness has been measured by means of an intrascope between the 2nd and 3rd last rib, and 60 mm from the midline of the carcass, while the carcass is in a hanging position; or

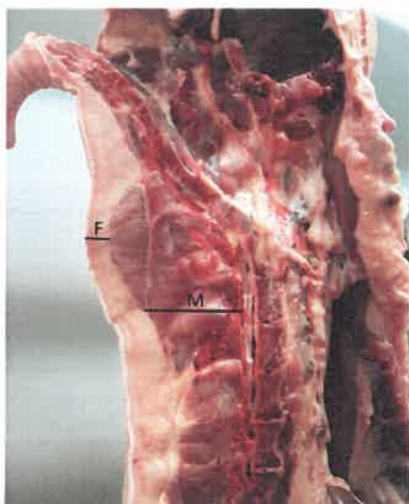


Figure 1: Measuring points for fat thickness (‘F’) and muscle thickness (‘M’); and

  - (c) the fat thickness (‘F’) and muscle thickness (‘M’) have been measured by means of a linear measuring device, such as a ruler or calliper, on the split carcass, respectively on the thinnest place above the *gluteus medius* muscle and the distance between the cranial (front) tip of the *gluteus medius* muscle and the dorsal (upper) edge of the vertebral canal, as indicated in Figure 1 below.

- (b) the substitution for sub-regulation (2) of the following sub-regulation:
- “(2) The percentage meat shall, depending on the measuring technique used, be calculated by means of the following formulae, where fat thickness and muscle thickness is expressed in mm:
- (a) Percentage meat with electronic thickness meter =  $68.052 - (0.830 \times \text{fat thickness}) + (0.068 \times \text{muscle thickness})$ .

- (b) Percentage meat with intrascope =  $70.952 - (0.891 \times \text{fat thickness})$ .
- (c) Percentage meat with linear measuring device =  $59.73 - (0.517 \times \text{fat thickness ('F')}) + (0.098 \times \text{muscle thickness ('M')})$ .”.

***Amendment of regulation 17 of the Regulations***

7. Regulation 17 of the Regulations is hereby amended by the substitution for sub-regulation (2) of the following sub-regulation:

- “(2) Each carcass shall be roller-marked --
- (a) warm on the day of slaughter, before entering the cold rooms; and
  - (b) under supervision of the independent qualified person, directly after classification.”.

***Amendment of regulation 18 of the Regulations***

8. Regulation 18 of the Regulations is hereby amended by the substitution for sub-regulation (3)(b) of the following sub-regulation:

- “(b) a goat that has been classified as age class --
- (i) A, be applied with blue ink; and
  - (ii) AB, B and C be applied with orange ink.”.

***Amendment of regulation 23 of the Regulations***

9. Regulation 23 of the Regulations is hereby amended by the substitution for sub-regulation (3) of the following sub-regulation:

- “(3) A quality indication shall not be marked or stamped on the container or outer container of meat or a carcass unless its use is approved by the executive officer on written request: Provided that where required --
- (a) the written request is accompanied by a protocol describing what the quality indication involves and proof of compliance to the protocol; and
  - (b) the owner of the quality indication shall also provide a short summary of the protocol together with contact details, for public information.”.

***Amendment of Table 3 in the Annexure to the Regulations***

10. Table 3 in the Annexure to the regulations is hereby amended by the substitution for Table 3 of the following Table:

WET OP LANDBOUPRODUKSTANDAARDE, 1990 (WET No. 119 VAN 1990)

**REGULASIES BETREFFENDE DIE KLASSIFISERING EN MERK VAN VLEIS BESTEM VIR VERKOOP IN DIE REPUBLIEK VAN SUID-AFRIKA: WYSIGING**

Die Minister van Landbou, Grondhervorming en Landelike Ontwikkeling het kragtens artikel 15 van die Wet op Landbouprodukstandaarde, 1990 (Wet No.119 van 1990), die regulasies in die Bylae uitgevaardig.

**BYLAE****Woordomskrywings**

1. In hierdie Bylae beteken “**die Regulasies**”, die regulasies gepubliseer by Goewermentskennisgewing No. R. 55 van 30 Januarie 2015.

**Wysiging van regulasie 1 van die regulasies**

2. Regulasie 1 van die Regulasies word hierby gewysig deur --

(a) die omskrywing van “**massa**” met die volgende omskrywing te vervang:

“‘**massa**’ met betrekking tot ‘n karkas, die warm massa soos tydens vleisklassifikasie bepaal;” en

(b) die volgende omskrywing na die omskrywing van “**vleisklassifikasie**” in te voeg:

“‘**week**’ met betrekking tot die ouderdom van ‘n beerkarkas, beteken die eerste week van die jaar wat die vroegste week met ten minste 4 of meer dae van die maand Januarie is en waar Maandag die eerste dag van die week is.”.

**Wysiging van regulasie 2 van die Regulasies**

3. Regulasie 2 van die Regulasies word hierby gewysig deur die volgende subregulasie na subregulasie (3) in te voeg:

“(4) Die beperking in subregulasie (1)(c) hierbo sal, waar nodig, nie in die volgende gevalle geld nie: Met dien verstande dat die gemagtigde skriftelik op ‘n jaarlikse basis deur die betrokke abattoir in kennis gestel sal word:

(a) Rolmerk van kalf-, bees-, skaap- en bokkarkasse, soos in regulasies 17, 18 en 19 voorgeskryf, wanneer sodanige karkasse vir uitvoer of verwerking bestem is.

(b) Aanbring van klassifiseringstempelmerke op varkkarkasse, soos in regulasie 15 voorgeskryf, wanneer sodanige karkasse vir uitvoer of verwerking bestem is: Met dien verstande verder dat klassifiseringsmerke steeds op die ore aangebring moet wees.”.

**Wysiging van regulasie 6 van die Regulasies**

4. Regulasie 6 van die Regulasies word hierby gewysig deur subregulasie (4) met die volgende subregulasie te vervang:

“(4) Alle karkasse wat geslag word by ‘n geregistreerde abattoir moet te alle tye, vir die doeleindes van ouderdomsklassifikasie, identifiseerbaar wees met die kop van sodanige karkas deur plakkers wat dieselfde genommer is aan die karkas en ooreenstemmende kop te heg: Met dien verstande dat in die geval van die kop die plakker uit ‘n etiket sal bestaan wat permanent aan die kop geheg is.”

**Wysiging van regulasie 11 van die Regulasies**

5. Regulasie 11 van die Regulasies word hierby gewysig deur --

(a) subregulasie (1) met die volgende subregulasie te vervang:

“(1) 'n Varkkarkas, insluitende die kop, met 'n massa van 20 kg of minder op die dag van slagting, word as die klas 'Speenvark' geklassifiseer.”;

- (b) subregulasie (2) met die volgende subregulasie te vervang:

“(2) 'n Varkkarkas, insluitende die kop, met 'n massa van 20,1 kg of meer maar nie meer nie as 110 kg op die dag van slagting, word as 'n klas, soos uiteengesit in kolom 1 van Tabel 3 van die Aanhangel, geklassifiseer indien die berekende persentasie vleis van die karkas is soos in kolom 2 van die tabel teenoor die betrokke klas vermeld: Met dien verstande dat beerkarkasse tot en met 22 weke ouderdom waarvan die nommer van die week van geboorte --

- (a) duidelik op een of beide van die ore gemerk is, tot en met 110 kg ingesluit mag word; of

- (b) nie duidelik of glad nie op een of beide van die ore gemerk is nie, net tot en met 100 kg ingesluit mag word.”; en

- (c) subregulasie (3) met die volgende subregulasie te vervang:

“(3) 'n Varkkarkas, insluitende die kop, met 'n massa van 110,1 kg of meer op die dag van slagting of 100,1 kg of meer vir beerkarkasse met onduidelike week van geboorte merk of sonder die week van geboorte merk op die oor/ore, sal as die klas 'Worsvark' geklassifiseer word.”.

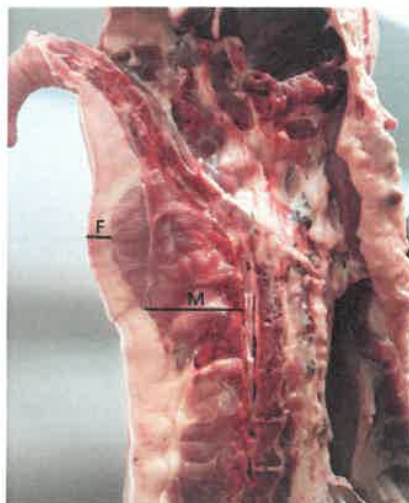
#### **Wysiging van regulasie 12 van die Regulasies**

6. Regulasie 12 van die Regulasies word hierby gewysig deur --

- (a) subregulasie (1) met die volgende subregulasie te vervang:

“(1) Die persentasie vleis van 'n varkkarkas word bereken nadat --

- (a) die vetdikte en spierdikte met behulp van 'n elektroniese diktemeter, tussen die 2de en 3de laaste rib, en 60 mm vanaf die middellyn van die karkas, gemeet is terwyl die karkas in 'n hangende posisie is;
- (b) die vetdikte met behulp van 'n intraskoop, tussen die 2de en 3de laaste rib, en 60 mm vanaf die middellyn van die karkas, gemeet is terwyl die karkas in 'n hangende posisie is; of
- (c) die vetdikte ('F') en spierdikte ('M') met behulp van 'n lineêre meetinstrument, soos 'n liniaal of skuifpasser, op die gehalveerde karkas gemeet is, op respektiewelik die dunste plek bokant die *gluteus medius* spier en tussen die kraniale (voorste) punt van die *gluteus medius* spier en die dorsale (boonste) rant van die rugmurgkanaal, soos hieronder aangedui in Figuur 1.

- (b) subregulasie (2) met die volgende subregulasie te vervang:

“(2) Die persentasie vleis moet, afhangende van die metingstegniek wat gebruik is, met behulp van die volgende formules bereken word, met die vetdikte en spierdikte in mm uitgedruk:

- (a) Persentasie vleis met elektroniese diktemeter =  $68.052 - (0.830 \times \text{vetdikte}) + (0.068 \times \text{spierdikte})$ .
- (b) Persentasie vleis met intraskoop =  $70.952 - (0.891 \times \text{vetdikte})$ .
- (c) Persentasie vleis met lineêre meetinstrument =  $59.73 - (0.517 \times \text{vetdikte ('F')}) + (0.098 \times \text{spierdikte ('M')})$ .”.

#### ***Wysiging van regulasie 17 van die Regulasies***

7. Regulasie 17 van die Regulasies word hierby gewysig deur subregulasie (2) met die volgende subregulasie te vervang:

“(2) Elke karkas moet --

- (a) warm gerolmerk word op die dag van slagting, voordat dit by die koelkamers ingaan; en
- (b) direk na klassifikasie onder toesig van die onafhanklike gekwalifiseerde persoon gerolmerk word.”.

#### ***Wysiging van regulasie 18 van die Regulasies***

8. Regulasie 18 van die Regulasies word hierby gewysig deur subregulasie (3)(b) met die volgende subregulasie te vervang:

“(b) 'n bok wat geklassifiseer is as ouderdomsklas --

- (i) A, aangebring word met blou ink; en
- (ii) AB, B en C aangebring word met oranje ink.”.

#### ***Wysiging van regulasie 23 van die Regulasies***

9. Regulasie 23 van die Regulasies word hierby gewysig deur subregulasie (3) met die volgende subregulasie te vervang:

“(3) 'n Gehalte-aanduiding mag nie op die houer of buitehouer van vleis of op 'n karkas gemerk of gestempel word nie tensy dit deur die uitvoerende beampte op versoek goedgekeur is: Met dien verstande dat waar nodig --

- (a) die geskrewe versoek met 'n protokol wat beskryf wat die gehalte-aanduiding behels, asook bevestiging van voldoening aan die protokol, vergesel is; en
- (b) die eienaar van die gehalte-aanduiding ook 'n kort opsomming van die protokol, tesame met kontak-besonderhede, vir publieke inligting sal voorsien.”.

#### ***Wysiging van Tabel 3 in die Aanhangsel tot die Regulasies***

10. Tabel 3 in die Aanhangsel tot die Regulasies word hierby gewysig deur die vervanging van Tabel 3 met die volgende Tabel:
